# Canada Company Awards Annual Scholarships to 10 Children of Canadian Forces Members who have Perished

Recipients Honoured at Historic Fort York Ceremony

**TORONTO, August 17, 2012** — The Honourable Peter MacKay, Minister of National Defence; Blake C. Goldring, Chairman of Canada Company and Chairman and Chief Executive Officer, AGF Management Limited; along with Lieutenant-General Peter Devlin, Commander of the Canadian Army today presented scholarships to the children of nine fallen Canadian Forces personnel.

The annual scholarships are provided as a tribute to fallen Canadian Forces personnel by a charitable business group called Canada Company. Each recipient will receive up to \$4,000 per year for up to four years – to help defray the costs of their post-secondary education.

The fifth annual awards ceremony was held at Historic Fort York in downtown Toronto. The Fort served as the primary harbour defence for the city between the 1790s and the 1880s and was the home of a military garrison until the 1930s.

During the War of 1812 it was also the site of the Battle of York, in which British, Canadian and First Nations combatants defended the Town of York (Toronto) against U.S. forces. Today, the Fort's walls enclose Canada's largest collection of original War of 1812 buildings.

"Historic Fort York is a fitting backdrop to honour these fine recipients. The Fort is an important part of our growth as a province and our military history," said Goldring. "The students understand the sacrifice that was made at this site 200 years ago. Their parents made the ultimate sacrifice when they made a commitment to serve our country and today our commitment is to help these students pursue their education."

"DND and the CF are committed to supporting and enhancing the quality of life of the military community, which includes families of fallen Canadian Forces members," said Minister MacKay. "I am gratified that organizations like Canada Company contribute so generously to this goal, and provide a meaningful tribute to the families of our fallen Canadian heroes."

"Canada Company and Blake Goldring continue to demonstrate extraordinary leadership and compassion as they work to help our military families. Today, we once again see their motto rings true - there truly are 'Many Ways to Serve'," said General Walt Natynczyk, the Chief of the Defence Staff. "On behalf of the men and women of the Canadian Forces and their families I wish to extend my heartfelt thanks to Canada Company for its great work and for this scholarship fund."

Natasha Roberge, daughter of the late Warrant Officer Gaétan Roberge and Ms. Monique Aubin, expressed thanks on behalf of the scholarship recipients and said, "As a student, it is difficult to balance finances and grades at the same time. Canada Company has greatly reduced some of the financial pressure as well as given me the opportunity to meet other Canadian Forces families that have lost a parent – something I might have otherwise never done."

The Canada Company Scholarship Fund will provide scholarship grants to children dating back to January 1, 2002.
