### Honouring The Often Forgotten: The Children Of The Fallen

Major Expansion Makes Canada Company Scholarship Fund Largest in The Country and Includes Children of Suicide Attributed to Military Service

Toronto, Ontario – June 24, 2016 – Children whose parents gave their lives in the service of our country were honoured at an event in Toronto today with senior military and business leaders in attendance. The group of 13 young men and women from across the country each received a Canada Company Scholarship to support their post-secondary education.

On the occasion of Canada Company's 10<sup>th</sup> Anniversary, the charity also announced a significant expansion to the scholarship program along with an additional \$500,000 in funding that will allow for the inclusion of children who have faced the death of a parent by military related suicide.

The expansion was made possible in part by \$100,000 in personal contributions from Canada Company's Board of Directors, matched by generous donations from BMO, RBC, Scotiabank and TD Bank Group. These donations will increase the total funding for the Canada Company



Scholarship Fund to over \$3 Million, providing financial support and opportunity to families of our men and women in uniform.

The Canada Company Scholarship Fund was established at the height of the Afghanistan conflict in 2006 to support children of those who lost their lives in that conflict. Since the first Scholarships were awarded in 2008, the program has evolved to include children who lost parents serving elsewhere. The expansion announced today will allow for an additional 125 Scholarships to be awarded.

"This Scholarship is an opportunity to honour and support the families of our heroes, those children whose lives were changed forever in defence of democracy for us, and for others. They are often the forgotten ones and they too are owed a great debt." said **HCol Blake C. Goldring, Founder and Chair of Canada Company and Chairman and CEO of AGF Management Limited.** 

"Today the battlefield has changed and as our country tries to come to terms with the broader impact of war, we recognize there is another group of children who need our support – the children who have lost a parent from suicide attributed to military service. Today we are proud to expand our Scholarship fund with the support of many patriotic Canadians to include those children as well. At Canada Company, we believe there are 'many ways to serve' and this is an important way we can help." he added.

"Every day, the remarkable men and women of the Canadian Armed Forces go above and beyond to maintain the safety and security of Canadians and individuals around the world," said the Honourable Harjit S. Sajjan, Minister of National Defence. "This program demonstrates Canada Company's recognition that we, as Canadians, have both a duty and an obligation to honour those who have made the ultimate sacrifice. To this year's Scholarship recipients, I would like to thank you personally for the sacrifices your families have made for this country, and wish you well in your post-secondary endeavours."

"I know the tremendous impact that programs like the Canada Company Scholarship Fund have on our military members and their families," said General Jonathan Vance, Chief of the Defence Staff, Canadian Armed Forces. "The Scholarship recipients reflect the highest ideals of service and sacrifice, and we are honoured to be working with Canada Company and its members to help support them as they pursue post-secondary education."

"Through the generosity of the Canada Company Scholarship Fund, all three of my children have been able to realize the dream of receiving a post-secondary education," said **Belinda Naismith, mother of three CCSF recipients Adam, Arina and Halsey.** "The ongoing commitment and support from Canada Company and The Canadian Armed Forces have made a very difficult period in our lives a little easier."

"Wounded Warriors Canada recognizes the importance of supporting military families and the need to do more. Often overlooked are the children who have lost a parent as a result of their service to Canada. It is why we were proud to recently announce our Veterans Post-Secondary Child Scholarship program and we applaud Canada Company for enhancing their Children of the Fallen Scholarship to include families affected by suicide deaths, attributable to military
