- Improved Reservist employment opportunities and working conditions easing their transition back to civilian life.
- Increased support for Reservists and their families.

Sharing the Sacrifice is endorsed by the Canadian Defence & Foreign Affairs Institute and supported by major employer groups including the Canadian Chamber of Commerce, Canadian Council of Chief Executives, and the Canadian Federation of Independent Business. The program is expected to be well received by members of the Canadian business community who have supported it throughout its development.

"Whether it's serving in peacekeeping efforts or in combat zones, military Reservists are a growing component of Canada's security at home and abroad," said Mr. Goldring. "Canada Company would like to thank the many people involved in the work leading up to today's great news, including the Prime Minister, the Minister of Finance, the Cabinet, Members of Parliament from all parties, partner organizations and the many Canadians who supported the initiative and advocated on behalf of Reservists and their families. We look forward to working with the Government of Canada, the military, and business community to develop and implement this program."
